### RESOLUTION NO. 13-111

**AUTHORIZING THE HONORABLE CITY MAYOR, JOHN GEESNELL L. YAP II, TO ENTER INTO CONTRACTS OF SERVICES WITH NON-PROFESSIONALS IN THEIR SPECIFIED FIELDS OF EXPERTISE, AS MAYBE DEEMED NECESSARY IN THE EXIGENCY OF THE SERVICES OF THE CITY GOVERNMENT, SUBJECT TO RATIFICATION BY THE SANGGUNIANG PANLUNGSOD, RETROACTIVE JULY 8, 2013**

**WHEREAS**, Section 9, Article II of our Philippine Constitution declares that; "The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all."

**WHEREAS**, Section 17, Article II on Basic Services and Facilities under the Local Government Code, the City Government is duly bound and mandated to fully implement the delivery of various basic services to the city constituents in line with its regulatory functions and responsibilities;

**WHEREAS**, it is within the sound discretion of the Honorable City Mayor to determine the needs and expertise required in pursuit of the abovementioned purpose(s);

**WHEREAS**, there is a dire need and extreme necessity of the City Government to hire competent and dedicated non-professionals to undertake and perform the above-mentioned services to the city constituents;

**WHEREAS**, it is imperative to hire the services of the said non-professionals to deliver the various basic services needed by the city on contractual basis;

**NOW THEREFORE, BE IT RESOLVED**, As It Is Hereby Resolved by the Twelfth Sangguniang Panlungsod of the City of Tagbilaran in session duly assembled:

To authorize the Honorable City Mayor, John Geesnell L. Yap II, to enter into Contracts of Services with Non-Professionals in their specified fields of expertise, as maybe deemed necessary in the exigency of the services of the City Government, subject to ratification by the Sangguniang Panlungsod, retroactive July 8, 2013.

**RESOLVED FURTHER**, that copies of this resolution be furnished to the Honorable City Mayor John Geesnell L. Yap II and to all offices concerned for their kind information, guidance and appropriate action.
