**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR JOHN GEESNELL L. YAP II ON BEHALF OF THE CITY OF TAGBILARAN, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL HOUSING AUTHORITY (NHA) REPRESENTED BY ATTY. CHITO M. CRUZ, GENERAL MANAGER, FOR THE HOUSING ASSISTANCE APPROVED BY THE NHA UNDER ITS HOUSING MATERIALS ASSISTANCE (HOMA) PROGRAM IN THE AMOUNT OF FIVE THOUSAND PESOS (PHP5,000.00) PER FAMILY IN THE DIFFERENT BARANGAYS OF THE CITY OF TAGBILARAN**

**WHEREAS**, the City of Tagbilaran has suffered severe devastation after a 7.2 magnitude earthquake struck the entire province of Bohol and some parts of the country on October 15, 2013 that left many houses totally damaged and others partially destroyed, with many families targeted for assistance;

**WHEREAS**, the National Housing Authority (NHA) approved an emergency assistance for the affected families in the amount of Five Thousand Pesos (Php5,000.00) per family under its Housing Materials Assistance (HOMA) Program;

**WHEREAS**, the fund will be solely used for the provision of housing materials to the affected households indicated in the Masterlist of Families Eligible for Housing Materials Assistance and Occupying "Build" Zones duly signed and certified by the City Social Welfare Development Office (CSWDO), and approved by the City Mayor John Geesnell L. Yap II;

**WHEREAS**, a Memorandum of Agreement (MOA) between the City of Tagbilaran and the National Housing Authority (NHA) is necessary for the implementation of the housing materials assistance from the NHA;

**NOW THEREFORE, BE IT RESOLVED**, As It Is Hereby Resolved by the Twelfth Sangguniang Panlungsod in session duly assembled, to authorize the Honorable City Mayor John Geesnell L. Yap II on behalf of the City of Tagbilaran, to enter into and sign the Memorandum of Agreement (MOA) with the National Housing Authority (NHA) represented by Atty. Chito M. Cruz, General Manager, for the housing assistance approved by the NHA under its Housing Materials Assistance (HOMA) program in the amount of Five Thousand Pesos (Php5,000.00) per family in the different Barangays of the City of Tagbilaran.

**RESOLVED FURTHER**, that copies of this resolution be furnished to the Honorable City Mayor John Geesnell L. Yap II, the City Social Welfare Development Office (CSWD), the National Housing Authority (NHA) for their information and guidance.
