APPROVING TEN (10) APPLICATIONS FOR RENEWAL OF FRANCHISE TO OPERATE MOTORIZED TRICYCLES FOR HIRE IN THE CITY OF TAGBILARAN

(Sponsored by: Hon. Jeremias C. Pabe, City Councilor)

WHEREAS, SECTION 447, paragraph 3 (vi) and SECTION 458, paragraph 3 (vi) of the Local Government Code of 1991 confers upon the city governments through the Sangguniang Panlungsod the power to regulate the operation of tricycles and the grant of franchise for the operation thereof within its territorial jurisdiction, subject to the guidelines prescribed by the Department of Transportation and Communication;

WHEREAS, ten (10) applications for franchise to operate motorized tricycles-for-hire have been endorsed to the Sangguniang Panlungsod of the City of Tagbilaran for consideration;

WHEREAS, each of the ten (10) applications have been duly evaluated and have complied with the requirements mandated under Ordinance No. C-211, Series of 2008 (Governing the Operation of Motorized Tricycles-for-hire in the City of Tagbilaran) and have already been posted in three conspicuous places in the City for not less than one week prior to this scheduled deliberation of the applications;

WHEREAS, no oppositions were registered by any interested party on the applications;

NOW THEREFORE, BE IT RESOLVED, As It Is Hereby Resolved by the Twelfth Sangguniang Panlungsod of the City of Tagbilaran in session duly assembled:

To approve the following ten (10) Applications for Renewal of Franchise to Operate Motorized Tricycles for Hire in the City of Tagbilaran, and for the issuance of the corresponding Franchise Certificate known as MOTOR TRICYCLE OPERATORS PERMIT (MTO), to take effect immediately upon the approval of this resolution and expiring three years thereafter, which Franchise Certificate shall at all times be subject to compliance with the provisions of Ordinance No. C-211 and other pertinent laws, to wit:
